



September 6th, 2018 CMTR Meeting Minutes

At approximately 11:07 am the board meeting started.

Board members Present were Shelli Ellis, Shannon Byerly, Chris Adams, Russ Johnson, Janie Anderson and Chad Bauer. Also present was Regional Training Coordinator, Jason Smith.

An introduction was conducted and a sign in sheet was passed around.

Jason Smith gave the financial report. As of the time of the meeting there was \$132,016.69 in the training line item, \$31,433.78 in the equipment line item, and \$27,310.33 in the scholarship line item.

Old Business:

1. Ammo request from Woodland Park for Sgt Holzwarth to use while attending Firearms Conference in Utah was approved by email. 1800 rds 40 cal and 1100 rds 223.

New Business:

1. ASP Instructor course November 27th-29th. Have to have at least 25 signed up by end of September. **Jason mentioned that the attendees will receive lots of free stuff in the class. There is also a \$50 deposit at time of registration. This is returned to the agency if the attendee shows up for the class.**
2. Upcoming Class: SRO Firearms (Sept 27 & 28), Driving Instructor Program (Oct 8-12), Train the Trainer (Oct 15-19), Smith & Wesson 2.0 Armorer (Nov 1st), Level I TA (Nov 5-9), Level II TA (Dec 3-14) and Level III TA (March 25-April 5).

The driving instructor class is full. The level I TA class will be held at Pueblo West Firestation #3. The level II TA class will be held at Fountain PD and the level III class will be held at Pueblo PD.

3. UCCS hosting a Training of Trainers (NOVA Defense) in Fountain September 24-28. **There will be no scholarship money approved for this class as CMTR will be hosting this class at no cost the following month. Just waiting on POST approval before posting to the website.**

Training Requests:

The following training requests were brought forth to be voted upon by the board:

- Woodland Park Police Department requests \$250 (only class fee) to send an officer to Leadership Training Performance and Accountability.
- Pueblo Police Department requests \$350 (only class fee) to send an officer to the Rocky Mountain Women in Law Enforcement.
- Pueblo Police Department requests \$650 (only class fee) to send an officer to the FBI-LEEDA Command Leadership Institute.

All of the requests were unanimously approved by the board members present. Board Member Chris Adams did not participate in the vote regarding the Woodland Park Police Department requests. Board Member Shelli Ellis did not participate in the vote regarding the Pueblo Police Department Requests.
